Challenge 3: Character Journal

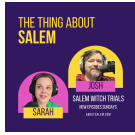
You are a Salem Village resident in early January 1692.

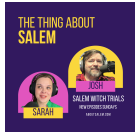

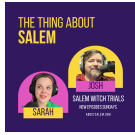
